

Appendix No. 2 to the regulations of the "Municipal Youth Activator" programme

**AGREEMENT

concluded in Lublin on ..... (*date*) between: the "Ulica Krótka" Association, with its registered office in Lublin, Ireny Kosmowskiej 1A/15, 20-815 Lublin, NIP 7123446441, KRS: 0001040441, represented by Idalia Mastalerz - Vice-President of the Management Board, hereinafter referred to as the Association,

and

Mrs./Mr. ...., residing at

number: ..... hereinafter referred to as the Project Initiator, and both above-mentioned Entities  
together hereinafter referred to as the Parties.

§1

1. The Project Initiator undertakes to carry out the task entitled:  
"....." hereinafter referred to as the project, the  
description of which is provided in Appendix No. 4 (Project Budget) and Appendix No. 5 (Project Schedule) to  
this agreement.

2. The Association allocates the amount of: ..... PLN gross (in words: ..... PLN gross)  
from the "Municipal Youth Activator" program for the implementation of the project in 2026.

3. The Project Initiator declares that, prior to signing this Agreement, he/she has read the regulations of the  
"Municipal Youth Activator" program, 2026 edition, and accepts its provisions. He/she further declares that  
he/she will comply with the provisions of the program regulations and this Agreement.

§2

1. The project promoter undertakes to:

a) preparation, implementation and supervision of the project in accordance with its description constituting  
Appendix No. 4 (Project Budget) and Appendix No. 5 (Project Schedule);

b) preparing, maintaining, supervising and carefully storing all documentation necessary for the proper  
performance of the Agreement;

c) providing the Association with a handwritten report on the implementation of activities carried out under the Municipal Youth Activator programme, prepared according to the template (Appendix No. 3), and photographic or video documentation of the Project carried out under the Municipal Youth Activator within 14 days of the end of the Project, with appropriate and unrestricted consent to their use (in addition to the signed paper version of the report, the Project Initiator should also send the completed form in an editable version to the Association's e-mail address: mam2026@ulicakrotka.com or attach it on a medium to the paper version of the form);

d) inform the Association on an ongoing and comprehensive basis about all events and circumstances that are in any way related to this Agreement and the event referred to in § 1 of the Agreement.

2. Under the concluded Agreement, the Project Initiator will be entitled to incur expenses to cover the costs necessary to implement the event specified in § 1 of the Agreement. The Project Initiator is obligated to spend these costs only in accordance with the budget and the submitted project application.

3. The Association will cover the costs incurred by the Project Initiator, referred to in Annex 4 (Project Budget) to the Agreement, in one of two ways:

a) payment of transfer invoices and/or bills issued to the Association;

b) reimbursement of incurred costs based on submitted invoices and/or bills issued to the Association.

4. In exceptional cases, funds for the implementation of the project may be transferred in the form of an advance payment.

5. Payments related to the implementation of the Project, considered eligible costs, will be made by the Association after acceptance of correctly issued bills (with "NIP", Tax Identification Number) or invoices presented by the Project Initiator, based on the following data: Stowarzyszenie "Ulica Krótka", with its registered office in Lublin, Ireny Kosmowskiej 1A/15, 20-815 Lublin, NIP 7123446441.

6. Apart from the amounts due specified in Annex 4 (Project Budget) to the Agreement, the Project Initiator shall not be entitled to any other financial claims against the Association under this Agreement.

7. The Project Initiator is obliged to provide the Association with correctly completed invoices or bills within a timeframe that allows for the proper and correct execution of the payment order by the Association.

1. The Project Initiator is obliged to promote the implemented project.
2. The Project Initiator must include an appropriate attribution bar on all promotional materials (both printed and online), as well as film materials, including reports from the Project's implementation, or other audio-video materials created as part of the Program. The Project Initiator will receive an appropriate attribution bar from the Association.
3. The Project Initiator consents to the recording of the Project (photo, audio, video) by persons authorized by the Association and the Lublin City Hall, as well as to the free and unlimited use of the recorded materials for the promotional and organizational purposes of the Municipal Youth Activator programme, the Lublin City Hall and the Association.
4. The Project Initiator undertakes to provide the Association with consents signed by adult participants (in the case of minors, the consents should be signed by their legal guardians) to record and use their image, i.e., photographs, films, recordings, etc., taken during the project referred to in §1. Materials containing their image will be posted on social media, on the website of the City of Lublin and the Association, and used in promotional materials. The aim is to promote the Municipal Youth Activator programme.

#### §4

1. The Association has the right to terminate the Agreement immediately in the event of:
  - a) gross violation of the terms of this Agreement by the other Party;
  - b) misuse of the transferred funds;
  - c) failure by a Party to take action to perform the Agreement in such a way that the performance of the Agreement becomes impossible or significantly more difficult.
2. The right to terminate the Agreement is exercised by submitting a written declaration to the other Party.
3. In the event of non-performance of the contract in whole or in part by the Project Initiator, the Project Initiator, in the event of receiving an advance payment for the implementation of the project, is obliged to return the unused amount.
4. The Project Initiator shall be fully liable for damages towards the Association and third parties for the implementation of this Agreement and for any damages and claims that may arise in this respect.

#### §5

1. The Parties declare their willingness to amicably resolve any disputes arising during the implementation of this Agreement.
2. If an amicable settlement is not possible, any disputes arising from the implementation or interpretation of this Agreement shall be resolved by the competent common court in Lublin.
3. In matters not regulated by the Agreement, the provisions of the Civil Code shall apply.

§6

Any changes to this Agreement must be made in writing to be valid.

§7

The contract is concluded for a fixed period, from the date of signing the contract until .....

The Agreement has been drawn up in two identical copies, one for each Party.
